CALL TO ORDER

Mayor Joseph Schultz called the meeting to order at 7:00pm.

PLEDGE OF ALLEGIANCE

Citizens Petition

Josh Nathaniel spoke to Council introducing a group that has been formed for better safety in our schools. The group is putting a plan together to have a levy put on the ballot that would allow an SRO officer at each of the area schools. They have 140 signatures so far. Mr. Nathaniel expressed they were just in the beginning stages and would be meeting with several people including the School Superintendent. Mr. Nathaniel explained how the levy would pay for the officers and possibly a therapist in schools. Dan Bucher asked about SPJ being included. They are not in these numbers but could definitely be looked at. They are funded privately.

Chief Durkee said he would like to see a task force.

The group will continue to meet with the goal of getting the levy on the ballot. Mr. Nathaniel will continue meeting with the City Manager to keep Council updated. Scott Svab thanked the group and said this was great and he appreciated the group's efforts.

Police Chief Swartz stated the department has been doing their reports at the school rather than the office so they have more of a presence at the schools.

Lea Nathaniel stated that they realize there is no one solution but prevention comes by talking now and everyone has to come together.

Mrs. Mayberry suggested the whole district also share in the cost.

Mr. Whittington stated that they would need to set up a Safety Committee so that all can be on the same page including Clinton and Lawrence Township.

REPORTS OF STANDING COMMITTEES

Sue Mayberry reported that the Finance and Personnel Committees met prior to the meeting and discussed deductible reimbursement with health insurance. The committee agreed to look at the existing ordinance and to move forward with the elimination of deductible reimbursement in future contracts. They will need to add an effective date to the legislation.

REPORTS OF ADMINISTRATIVE OFFICERS

Senior Citizens – Kathy Snyder reported that the Center is available seven days a week. The rental fee is reasonable. Mrs. Snyder stated the members will be going on several trips including Mt. Rushmore and Tennessee. Mrs. Snyder also said that Easter Candy is on sale now at the Center.

Mrs. Snyder stated they are applying for the Aultman Foundation Grant for their Wellness program. Mrs. Snyder said she is now a certified Silver Sneakers teacher. If they receive the grant, they will open the building on Wednesdays in the future.

Fire Chief - Chief Ray Durkee stated they had a fire call this past Friday. It was a routine call with no injuries.

Chief Durkee reported that he would like a voice motion on adding a fourth person Tuesday, Wednesday and Thursday nights. He stated that due to retirements in the department they could stabilize this schedule.

Mr. Rouse stated that the Chief was willing to do with one less Captain and EMS collections exceeded last year.

Chief Durkee stated they would start in April.

Police Chief – Police Chief Doug Swartz commended the officers that were involved in the recent suicide tragedy. The officers were in a wooded area. They did not know who the individuals might be but did know that a firearm may be involved. The Chief stated that they are questioned on what they are doing since the Florida shooting to make our kids safe. The Chief stated that they do not have to have a knee-jerk reaction. They have active shooter training in our schools presently. Chief Swartz stated he is confident on where we are and this is a never-ending process. He would like to express that the students are always on their mind and the department is on it.

Chief Swartz said there would be a Disconnect to Re-connect day on March 10th where he urges all to stay off of electronics and social media for the day.

Mayor Schultz stated there will be a fitness test on March 20 for the officers' incentive program and he would like to extend that benefit to Chief Swartz.

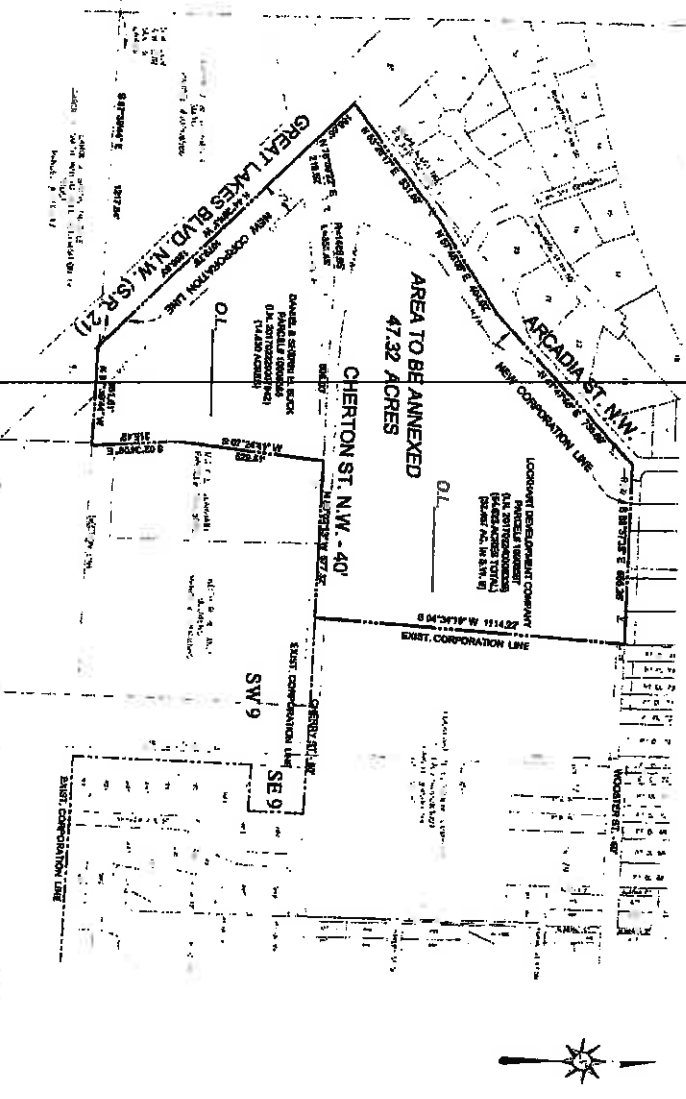

AN ORDINANCE BY THE

AMENDING ORDINANCE NO.
19-85.

WHEREAS, City Council and the Administration wish to amend the Ordinance No. 19-85.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CANAL FULTON, THAT:

SECTION 1. Ordinance No. 19-85, section (e) and any subsequent amendments thereto addressing health insurance which currently state "The City will provide hospitalization and medical insurance on the full-time employees on a voluntary basis. The hospitalization and medical insurance plans are not available to part-time or seasonal employees, and volunteers. The employees shall pay fifteen percent (15%) of the total premium and the City will pay eighty-five percent (85%) of the total premium" shall be repealed and replaced with the language in Section 2 below.

SECTION 2. Ordinance 19-85 Section (e) shall in accordance with Section 4 below provide "The City shall provide health and benefit Insurance Programs as determined by the City to all full-time employees as otherwise required by law. All Employees enrolled in the Insurance Programs shall contribute monthly toward the premium cost for said insurance at the rates established by the City. There shall be no reimbursement by the City to employees of out of pocket costs or deductibles."

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in accordance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

WHEREAS, the Council of the City of Canal Fulton, Ohio desires to amend Chapter 131 of the Department of Fire Services.
